Articles must be original and not currently under review elsewhere. Submitted articles are subject to a blind, peer review process. Please adhere to the guidelines below when preparing submission for the journal.

Academic Article 10-20 pages
Research Article 10-25 pages
Article Review 10-25 pages

(All manuscripts will be subject to anonymous peer review.)

#### Format of submissions

Manuscripts can be in English or Thai. Thai manuscript must be prepared using Angsana UPC 16 point, and English manuscript must be prepared using Times New Roman 12 point; 1.0 inch margins.

**Title:** Should be concise and informative.

Authors: Give the full name of all authors (no title), their affiliations and addresses. Please specify a

corresponding author with an asterisk (\*).

**Abstract:** Not exceeding 300 words. Clearly summarize the important findings of the paper.

It should contain hard facts such as objectives, methods and major results.

(Every manuscript must have both Thai and English versions for title, authors and abstract. The English version is written before the Thai version.)

**Keywords:** Provide 4-6 keywords which can be used as an index to direct readers to articles.

**Figures:** Figures must be placed near their references. Caption and number of a figure must be located

below the figure. Please ensure that your figures are clear when printed with black and white

printers.

**Tables:** Tables must be placed near their references. Caption and number of a table must be located above

the table.

# Acknowledgments (if any):

List sources of financial or material support and the names of individuals whose contributions were significant but not deserving of authorship.

**References:** List all works cited in the text and only these. List them in alphabetical order by author name.
